The Namakkal Consumer Disputes Redressal Commission vide the order dated January 19, 2024, which was received by the Company on January 25, 2024, held that the Company is liable to pay Rs.10,50,000/- as compensation to the Claimant. Out of this Rs.10,50,000, Company has already paid Rs. 5,00,000 based on a mutually agreed settlement.

We have planned to file an appeal before the State Consumer Dispute Redressal Commission. We will continue to update the Stock Exchanges in the event of any further material developments in this matter.
