Pursuant to Regulation 30 of SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015, we hereby inform you that the Company's wholly owned subsidiary, ATS Elgi Limited has received a show cause notice on January 31, 2024, in form DRC-01 from GST Department relating to the financial year 2018-19 for its Telangana State branch. GST Department has imposed a penalty 10% of tax due, i.e Rs 41,018 or Rs. 10,000, whichever is higher.

ATS Elgi Limited does not accept the demand and will defend the proposals mentioned in the show cause notice and will file the objections in DRC-06 within 15 days of this notice.
